#### ORDER:

The Government of Puducherry, upon republishing the Resolution and CCS(Revised Pay) Rules, 2016 dt.25.07.2016 notified by the Government of India, Ministry of Finance, Department of Expenditure towards acceptance of Seventh CPC recommendations vide G.O. 1<sup>st</sup> read above for implementation in this Administration, has issued comprehensive instructions on the method of fixation of pay/pension/family pension under the CCS(Revised Pay) Rules 2016 vide G.O. 2<sup>nd</sup> read above.

- 2. Now, certain amendments to the said Resolution and CCS(Revised Pay) Rules, 2016 notified by the Government of India, Ministry of Finance, Department of Expenditure through Resolution dt.16.05.2017 and CCS(Revised Pay) (Amendments) Rules dt.15.06.2017 have been republished by Government of Puducherry vide G.O. 3<sup>rd</sup> read above which includes enhancement of IOR of Level 13 of Civil Pay Matrix from 2.57 to 2.67 and substitution of the revised Civil Pay Matrix in Part A of CCS(Revised Pay) Rules 2016.
- 3. The revised pay structure prescribed to the Level 13 of  $7^{th}$  CPC Civil Pay Matrix in terms of the G.O.  $3^{rd}$  read above shall be implemented in this Administration with effect from 01.01.2016 by adhering to all the instructions contained in G.O.  $2^{nd}$  read above, in particular, the following:
- (i) Revised Pay/Pension/Family Pension under Seventh CPC Pay Matrix shall be paid from September 2016 onwards.
- (ii) Orders with regard to payment of arrears on account of revised pay and pension with effect from 01.01.2016 to 31.08.2016 shall be issued separately.
