**NOTIFICATION**

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, read with the Notification No.F.5/4/65-GP, dated 11<sup>th</sup> January, 1965 of Government of India, Ministry of Home Affairs, New Delhi and in supersession of Government of Puducherry Finance Department Notification issued in G.O.Ms.No.22/82/F5, dated 21<sup>st</sup> January 1982, or published in Supplement to the Gazette No. 5, dated 02.02.1982, save as respects, things done or omitted to be done before such supersession, the Lieutenant-Governor, Puducherry, hereby makes the following rules, regulating the method of recruitment to the Group 'B' Gazetted post of Budget Officer in the Finance Department, Government of Puducherry, namely :-

1. Short title and commencement.-

- (1) These rules may be called the Government of Puducherry, Finance Department, Group 'B' Gazetted post of Budget Officer Recruitment Rules, 2020.
- (2) They shall come into force on and from the date of their publication in the Official Gazette.

2. Number of posts, its classification and Level in the Pay Matrix. - The number of said post, its classification and the Pay Matrix attached thereto, shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.

3. Method of recruitment, age limit and other qualifications etc. - The method of recruitment to the said posts, age limit, qualifications and other matters relating thereto, shall be specified in columns (5) to (13) of the said Schedule.

4. Disqualifications. - No person, -

- (a) who has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Lieutenant-Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax.- Where, the Lieutenant-Governor is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.


6. Savings.- Nothing in these rules shall affect the reservations, relaxation in upper age limit and other concessions required to be provided for the Scheduled Castes/ Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Government from time to time in this regard.
