### OFFICE MEMORANDUM

Subject: Coverage under Central Civil Services (Pension) Rules, 1972 of those Central Government employees whose selection for appointment were finalized before 01.01.2004 but joined Government service on or after 01.01.2004.

In continuation to this Department's O.M of even number dated 17.02.2020 providing one-time option to Government servants for coverage under Central Civil Services (Pension) Rules, 1972 in place of National Pension System who were declared successful for recruitment in the results declared on or before 31.12.2003 against vacancies occurring before 01.01.2004 and are covered under the National Pension System on joining service on or after 01.01.2004.

- 2. The said Office Memorandum provides for cut off dates for various activities involved in the process of exercising of option, deciding representations by appointing authorities and closure of NPS accounts of the concerned Government servants.
- 3. In view of the country-wide lockdown in the country due to outbreak of Covid -19 pandemic and references received from some Ministries / Departments for extension of time schedule prescribed in the said OM, in partial modification of this Department's OM of even number dated 17.02.2020, it has been decided to extend the above cut-off dates as under:

Time-limit for submission of claims for Travelling Allowance (TA) on Retirement -Subject: regarding.

The undersigned is directed to refer to this Department's OM No. 19030/1/2017-E.IV dated 13.03.2018 wherein the time limit for submission of claims for TA on Tour/Transfer/Training/ Journey on Retirement was changed from one year to sixty days, succeeding the date of completion of the journey.

- Several references have been received in this Department regarding extension of time-limit for 2 submission of TA claims in r/o journeys performed by retired employees and their families for going to Home town/place of settlement after retirement as difficulties are being faced by the retired Govt. officials while claiming reimbursement of TA on retirement within a period of sixty days of completion of their journey.
- The matter has been considered in this Department and in partial modification of this Department's 3 OM of even number dated 13.03.2018, it has been decided that the time-limit for submission of claims for TA on Retirement is modified from 60 days to 180 days (six months), succeeding the date of completion of the journey.
- The time limit for submission of TA claim on tour, transfer and training will remain 60 days. 4
- These orders will be effective from the date of issue of the order. However, the claims not settled 5 due to time limit of 60 days in terms of the O.M. dated 13.03.2018 on the subject, may be re-considered by the concerned Ministry/ Department.
- In their application to the persons belonging to Indian Audit and Accounts Department, these orders are issued under Article 148(5) of the Constitution and after consultation with the Comptroller & Auditor General of India.
- This is issued with the approval of Finance Secretary & Secretary (Expenditure). 7.
