

222. The organisations which are running in profit will automatically give bonus as per the regulations and the administrative orders issued earlier.

223. There are Public Sector Undertakings (PSUs) which are on loss and other Autonomous Bodies such as Boards, Societies wherein regular salaries was not paid for quite sometime. In the recent budget, announcement was made that atleast two months salary to be given to all the organisations stated above.

224. As Deepawali is the main festival celebrated, we may extend sanctioning a Gift amount of Rs.2,000/- (Rupees Two thousand only) as a special case to all the employees of such PSUs, Boards and Societies where even salaries was not paid regularly. We may advise the corporations, societies and autonomous to submit proposals for sanctioning gift amount for Deepawali.
