ORDER

Approval of Hon'ble Lieutenant Governor is hereby conveyed for the extension of revised pay scales applicable as per CCS (Revised Pay) Rules, 2016 following the recommendations of Seventh Central Pay Commission to the regular staff/ employees of the following four Autonomous institutions/ boards run by the departments of School Education, Agriculture and Science & Technology of the Government of Puducherry :-

2. The approval is subject to the following :-

- (i) The revised pay scales shall be effective from 01.01.2016 but monetary benefit with effect from the month of **April 2022**.
- (ii) The Administrative Departments/ Institutions concerned shall examine the applicability of revised pay scales in the light of CCS(Revised Pay) Rules, 2016 to the regular staff/ employees based on their service conditions, recruitment rules and pattern followed during Sixth CPC and take a cautious decision accordingly before granting the revised pay scales.
- (iii) This G.O. shall serve only for the purpose of grant of revised pay scales and allowances applicable consequent on the implementation of Seventh CPC recommendations. Changes in service conditions if any to the employees of these institutions by virtue of CCS(Revised Pay) Rules, 2016 shall be examined and decided by the concerned Administrative Department separately.

- (iv) The orders of Government of India on revision of rates of allowances as per Seventh CPC recommendations which are specifically communicated by Finance Department, Puducherry for implementation to the employees of this Administration shall only be extended to the eligible employees of Autonomous institutions/ boards. In respect of other allowances, status quo shall be maintained until further orders thereof from Finance Department, Puducherry.
- (v) The Administrative Departments/ Institutions concerned shall ensure availability of sufficient funds in the budget to meet out the additional financial implications on account of grant of revised pay scales.
- (vi) The said Autonomous institutions/ boards shall extend the revised pay scales as per recommendations of Seventh Central Pay Commission to its employees after obtaining the approval of Governing Body/Board concerned.
