Sub: Finance Department – Grant of enhanced rate of Dearness allowance to the employees/employees of Autonomous Bodies of the UT of Puducherry continuing to draw their pay in the Pay Scale/ Grade Pay as per 6<sup>th</sup> CPC recommendations – Orders – Communicated.

Attention is invited to the reference cited, wherein the Ministry of Finance, Government of India has revised the rate of Dearness Allowance from 239% to 246% with effect from 01.07.2024 to the Employees of Central Government and Central Autonomous Bodies continuing to draw their pay in the pay scale/Grade Pay as per 6<sup>th</sup> Central Pay Commission recommendations.

2. Copy of Office Memorandum cited is forwarded herewith for information and implementation, subject to the condition that the Institutions/Bodies may meet the above additional expenditure from their own resources. The administrative Departments may also allocate funds for this purpose within their budget allocation without seeking any additional fund/Grant in Aid from Government. The PSUs/Autonomous Bodies, etc., of this UT Administration may claim the enhanced rate of Dearness Allowance depending upon the availability of funds with the respective organisation.

3. Implementation of enhanced rate of Dearness Allowance from 239% to 246% with effect from 01.07.2024 is also applicable to those eligible Government Employees/Pensioners/Family Pensioners /FTCLRs and equivalent categories of staff who have been duly engaged with the approval of the Competent Authority, who are continuing to draw their pay/pension/wages as per 6<sup>th</sup> CPC recommendations.



Subject: Revision of Dearness Allowance to the employees of Central Government and Central Autonomous Bodies continuing to draw their pay in the pay scale/Grade Pay as per 6<sup>th</sup> Central Pay Commission

The undersigned is directed to refer to this Department's O.M. No. 1/3(1)/2008-E.II(B) dated 3<sup>rd</sup> June, 2024 on the subject mentioned above and to say that the rate of Dearness Allowance (DA) in respect of employees of Central Government and Central Autonomous Bodies, who are continuing to draw their pay in the pre-revised pay scale/Grade Pay as per 6<sup>th</sup> Central Pay Commission, shall be enhanced from the existing rate of 239% to 246% of Basic Pay w.e.f. 01.07.2024.

2. The provisions contained in paras 3, 4 and 5 of this Ministry's O.M.No.1(3)/2008-E.II(B) dated 29<sup>th</sup> August, 2008 shall continue to be applicable while regulating Dearness Allowance under these orders.
3. The contents of this Office Memorandum may also be brought to the notice of all organisations under the administrative control of the Ministries/Departments which have adopted the Central Government scales of pay.
4. This issues with the approval of Competent Authority.
