

**NOTIFICATION**

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India, read with the Notification No.F.5/4/65-GP dated 11<sup>th</sup> January, 1965 of the Government of India, Ministry of Home Affairs, New Delhi, and in supersession of the Notification issued in G.O.Ms.No.20/94/F5, dated 9<sup>th</sup> March 1994 and published in Supplement to Gazette No.14 of the 5<sup>th</sup> April, 1994, save as respects things done or omitted to be done before such supersession, the Lieutenant Governor, Puducherry, hereby makes the following rules regulating the method of recruitment to the Group 'B' post of Store Superintendent in various departments of the Government of Puducherry, namely:-

1. Short title and commencement:-

(a) These rules may be called the Government of Puducherry, Store Superintendent Recruitment Rules, 2022

(b) They shall come into force on the date of their publication in the Official Gazette

2. Application:-

These rules shall apply to the posts specified in column 1 of the Schedule annexed to these rules.

3. Number of post, classification and Scale of Pay :-

The number of post, its classification and the Pay Level or Pay Scale attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.

4. Method of recruitment, age limit, other qualifications, etc.:-

The method of recruitment, age limit, qualifications and other matters relating to the said post shall be as specified in columns 5 to 13 of the said Schedule.

5. Disqualification:- No person, -

(a) who has entered into or contracted a marriage with a person having a spouse living; or

(b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post;

Provided that the Lieutenant Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

6. Power to relax:-

Where the Lieutenant Governor is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing and in consultation with Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

7. Saving:-

Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Caste, the Scheduled Tribes, ex-servicemen and other Special Categories of persons in accordance with the orders issued by the Government from time to time in this regard.
