### ORDER

The Government of Puducherry is pleased to constitute an **EXPERT COMMITTEE** to study the viability of restoring the financial health, etc., of the State Owned Loss making Public Sector Undertakings / Autonomous Bodies of the Union Territory of Puducherry and the list of such Organizations is at Annexure.

2. The composition of the Expert Committee is as follows:-

3. The terms and references of the Expert Committee will be as follows:-

- To conduct Techno-economic feasibility study for revival of the organisations.
- To study the exact man-power requirement of the Organization and to state whether it is adequate / excess with reference to the activities of the Organization and suggest measure for maximum utility of man-power as well as improve man-power skill.
- To study and suggest measure to be made in respect of Modernisation of Machinery, equipments, Managerial techniques, diversification of business activities.

- d) To study the previous reports / recommendations, if any, of any of the Expert Committee(s) constituted in the recent days on any of the PSUs / Autonomous Bodies, and based on their recommendations, a clear road map may be evolved / worked out immediately, for such Organizations.
- e) To review the release of GIA made by the Government of Puducherry and suggest possible measures for running the Institution by a self financing one and self sustaining one.
- f) To examine the feasibility of running the unit/organization through a best mode viz. Public Private Participation (PPP), Long Lease basis, etc.

4. In order to achieve the goal at para 3(d), it is desired that if there are any such Committee(s) already existing for this purpose, a report may be placed before this Expert Committee for conclusion/recommendation.

5. The Chairman may invite any appropriate Expert(s) people in the connected field of the concerned Organization for deliberations in the Committee.

6. In case any necessity arises, the concerned Administrative Secretary may be invited by the Chairman as "Co-opted Member".

7. The concerned Head of Department will immediately finalize the schedule of meetings and the data/details required for study shall be submitted to the Committee, within a week time, from the date of the G.O.

8. The concerned Head of Department shall make all arrangements to conduct meetings; prepare Agenda & Proceeding after getting approval of the Chairman and carry out all the direction of the Expert Committee.

9. The Director of Planning & Research shall arrange /provide required office room, manpower support, conveyance, etc., for the Chairman of the Committee to look after the day-to-day official work.

10. The expenses, in respect of Chairman of the Committee, viz. TA, DA, conveyance, other incidental expenses, consolidated fees / remuneration, etc., if any, shall be borne under the budgetary support of the Planning & Research Department, Puducherry.

11. The expenses, in respect of all other Members of the Committee, viz. TA, DA, Honorarium, consolidated fees, conveyance, other incidental expenses, etc., if any, and expenses in connection with conduct of meeting(s) including refreshment charges, materials, etc., shall be borne under the budgetary provision of the concerned Nodal Departments or Organisations.

12. The Reports/ Recommendations of the Expert Committee along with specific remarks of the concerned Administrative Departments on each points of Committee's recommendations, shall be submitted to Government for consideration/ action, within 15 days from the receipt of report from the Expert Committee.

13. The Expert Committee shall submit its report/ recommendations to Government within **"Three months"** from the date of constitution of the committee.
