Sub: Switching over to FTTH Connectivity for Internet by the Departments instead of Leased Line Connectivity under PSWAN.

Ref: Circular No. 762/DIT/PSWAN/D2/2019/2345, dt. 25.01.2022, of the Directorate of Information Technology, Puducherry

In pursuance of the Circular dated 25.01.2022 of the Directorate of Information Technology, Puducherry, cited under reference, the Administrative Departments/Offices listed in the Annexure are hereby directed to immediately switch over to a FTTH internet connection, and discontinue the use of Leased Line connectivity under PSWAN, owing to PSWAN being costlier and also offering relatively poor connectivity.

2. No expenditure shall be incurred by the said Departments/Offices towards internet charges via the lease line connectivity under PSWAN beyond 31.05.2022, and the Directorate of IT shall discontinue leased line connectivity to these Departments from 01.06.2022.

3. The concerned Departments/Offices shall in this regard scrupulously follow the guidelines issued by the Directorate of Information Technology vide the Circular cited under reference.

4. The financial powers are vested with Administrative Secretaries, vide the G.O.Ms. No. 47/FD/F3/2014, dated 09.12.2014 of the Finance Department, for sanctioning expenditure towards availing a new FTTH connection, and the concurrence of the Finance Department is not required for the purpose.
