## OFFICE MEMORANDUM

Sub: Finance Department – Payment of bonus to the employees of Public Sector Undertakings and all Autonomous Bodies for the accounting year 2016-17 – Orders – Issued.

The matter regarding declaration of Productivity Linked Bonus plus ex-gratia for the accounting year 2016-17 to the employees of all Public Sector Undertakings and Autonomous Bodies such as Boards, Corporations and all Societies registered under Companies Act/ Co-operative Act under the Government of Puducherry was under consideration of the Government.

- 2. It has been decided that the employees of the Public Sector Undertakings and Autonomous Bodies such as Boards, Corporations and all Societies registered under Companies Act/Co-operative Act under the Government of Puducherry shall be paid Productivity Linked Bonus for the accounting year 2016-17 at the same rate and limit as was paid for the accounting year 2015-16.
- 3. Over and above the admissible bonus of 8.33% of salary or wages earned during the Accounting year 2016-17 irrespective of financial earnings of individual Public Sector Undertakings and Autonomous Bodies such as Boards, Corporations and all Societies registered under Companies Act/Co-operative Act may take conscious decision themselves for payment of ex-gratia, depending upon its allocable surplus in the relevant account year, as provided under Section 11 of Payment of Bonus Act.
- 4. It should be ensured that the bonus plus ex-gratia shall not exceed the maximum limit of Rs.11,000/- (Rupees eleven thousand only) per person.
- 5. The funds required for this purpose shall be managed only out of their own overall resources of Public Sector Undertakings and Autonomous Bodies such as Boards, Corporations and all Societies registered under Companies Act/Co-operative Act. In case of deficit of funds, the concerned Nodal Department/Administrative Department may send requisite proposal for modification of funds within their Budget Outlay immediately so as to facilitate the Autonomous Bodies under their Control to meet the expenditure on this score.

6. All the Public Sector Undertakings and Autonomous Bodies such as Boards, Corporations and all Societies registered under Companies Act/Co-operative Act shall comply with these instructions strictly.
