

Attention is invited to the references cited, wherein the Ministry of Finance, Government of India has revised the rate of Dearness Allowance from 221% to 230% and from 230% to 239% to the Employees of Central Government and Central Autonomous Bodies continuing to draw their pay in the pre-revised pay scale/Grade Pay as per 6th Central Pay Commission (viz., 221% to 230% w.e.f. 01.07.2023 and 230% to 239% w.e.f.01.01.2024).

2. Copy of Office Memorandums cited are forwarded herewith for information and for implementation, subject to the condition that the Institutions/Bodies may meet the above additional expenditure from their own resources. The administrative Departments may also allocate funds for this purpose within their budget allocation without seeking any additional fund/Grant in Aid from Government The PSUs/Autonomous Bodies, etc., of this UT Administration may claim the enhanced rates of DA depending upon the availability of funds with the respective organization.

3. Implementation of enhanced rates of Dearness Allowance from 221% to 230% w.e.f. 01.07.2023 and from 230% to 239% w.e.f.01.01.2024 is also applicable to those eligible Government Employees/Pensioners/Family Pensioners and for the FTCLRs and equivalent categories of staff who have been duly engaged with the approval of the Competent Authority, who are continuing to draw their pay/pension/wages as per 6th CPC recommendations.
