NOTIFICATION

In exercise of the powers conferred by the proviso to Articles 309 of the Constitution of India read with the Notification No.F.5/4/65-GP dated 11th January, 1965 of the Government of India, Ministry of Home Affairs, New Delhi and in supersession of (i) the Planning and Development Department's Notification No.29622/65-stt, dated 28th October, 1966 (ii) the Finance Department's Notification in G.O.No.372/Press, dated the 24th December, 1968 (iii) in G.O.No.373/Press dated 24th December, 1968, (iv) in G.O.No.374/Press, dated 24th December 1968 and in G.O.Ms.No.11/82/F2 of Finance Department dated the 8th January, 1982 in relation to the post of Statistical Inspector, the Lieutenant Governor, Pondicherry hereby makes the following rules regulating the method of recruitment to the Group 'C' (Non-Gazetted) Non-Ministerial post in the Directorate of Economics and Statistics, Pondicherry, namely:-

- 1. <u>SHORT TITLE AND COMMENCEMENT:</u> (I) These rules may be called the Government of Pondicherry, Group 'C' post of Statistical Inspector (Directorate of Economics and Statistics) Recruitment Rules, 2002.
 - (II) They shall come into force from the date of their publication in the Official Gazette.
- 2. <u>NUMBER OF POST, ITS CLASSIFICATION AND SCALE OF PAY:</u> The number of the said post, its classification and scale of pay attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed thereto.
- 3. METHOD OF RECRUITMENT, AGE-LIMIT AND OTHER QUALIFICATIONS: The method of recruitment to the said post, age limit, qualifications and other matters relating thereto shall be as specified in columns 5 to 14 of the said Schedule.
- 4. Disqualifications, -No person,
 - a) who has entered into or contracted a marriage with a person having a spouse living; or
 - b) who, having a spouse living, has entered into or contracted a marriage with any person

shall be eligible for appointment to the said post. Provided that the Lieutenant Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are grounds for so doing, exempt any person from the operation of this rule.

- 5. <u>POWER TO RELAX:</u> Where the Lieutenant Governor is of the opinion that it is necessary of expedient so to do, he may, by order and for reasons to be recorded in writing, relax any of the provisons of these rules with respect to any class or category of persons.
- 6. <u>SAVING</u>: Nothing in these rules shall affect the reservations, relaxations in upper age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes and other special category of persons in accordance with the orders issued by the Government from time to time in this regard.

RECUITMENT RULES FOR THE POST OF STATISTICAL INSPECTOR

2.	Number of Post	61 (sixty one) (2002) Subject to variation dependent on work load.
3.	Classification	General Central Service - Group 'C' - Non- Gazetted- Non-Ministerial.
4.	Scale of Pay	Rs.5000-150-8000
5.	Whether selection-cum-seniority or selection by merit or Non- selection post.	"Selection"
6.	Age limit for direct recruits	Between 18 and 32 years. Note-1: Relaxable for Government Servants upto 40 years in accordance with the orders or instructions issued by the Government provided such Government servants are working for not less than 3 years in posts which are in the same line or allied cadres and where a relationship can be established that the services rendered by them in the department will be useful for efficient discharge of duties in the post for which selection is made. Note-2: The crucial date for determining the age limit shall in each case, be the last date upto which the employment exchanges are asked to submit the names.

8.	Educational & other qualifications required for direct recruits.	Post Graduate Degree from recognized University in Economics/Statistics/Mathematics or its equivalent.

10. Period of probation

Two years (for direct recruits)

1. Method of recruitment whether by direct recruitment or by promotion or by deputation/ absorption and percentage of posts to be filled by various methods

By promotion failing which by direct recruitment and by direct recruitment on 3:1 ratio basis.

 In case of recruitment by promotion/deputation/absorption, grades from which promotion/ deputation/absorption to be made. Promotion from the grade of Computor/Field Supervisors with eight years of regular service in the post (in the scale of pay of Rs. 4000-6000). Note:

The Computors who were appointed prior to the issue of the G.O.Ms.No.27/2001/F3 dt.17.7.2001 of Finance Department are to be considered for promotion to the post of Statistical Inspector in the first instance and as and when they get promoted, the resultant vacant posts shall be treated as abolished. In the case of Field Supervisors they are to be taken up for consideration for promotion only after the existing Computors appointed prior to the date of the above G.O. are promoted.

Note:

If juniors who have completed their qualifying/ eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying/eligibility service by more than half of such qualifying/eligibility service or two years whichever is less and have successfully completed their probation period for promotion to the next higher grade along with the juniors who have already completed such qualifying/elegibility service.
